Notice of Change in Control

Dear Mr. Anderson:

Lake Charles Exports, LLC ("LCE") and BG LNG Services, LLC ("BGLS") are hereby filing a Notice of Change in Control ("Notice") in the above-referenced dockets. This Notice is provided pursuant to Department of Energy Office of Fossil Energy's ("DOE/FE") Procedures for Change in Control Affecting Applications and Authorizations to Import or Export Natural Gas.¹

On February 15, 2016, Royal Dutch Shell plc ("Shell") acquired all of the share capital of BG Group plc ("Transaction"). Prior to the Transaction, LCE was owned by subsidiaries of BG and Energy Transfer Equity, L.P. ("ETE"), and BGLS was an indirect wholly-owned subsidiary of BG. As a result of the Transaction, LCE is now owned by subsidiaries of Shell and ETE. BGLS is now an indirect wholly-owned by subsidiary of Shell. The authorizations and pending application to which this Notice applies are described below.

LCE

On May 6, 2011, as amended on May 26, 2011, LCE filed an application for authorization to export 730 Bcf per year of natural gas to Free Trade Agreement ("FTA") and non-Free Trade Agreement ("non-FTA") countries ("Application"). On July 22, 2011, DOE/FE granted LCE authorization to export LNG to FTA countries in Order No. 2987 ("FTA Authorization"). DOE/FE conditionally granted LCE authorization to export LNG to non-FTA countries in Order No. 3324, which was issued on August 7, 2013. The final non-FTA authorization is currently pending in Docket No. 11-59-LNG.

Through this Notice of Change in Control, LCE is (i) amending the FTA Authorization and (ii) requesting approval of an amendment to the pending portion of the Application for non-FTA authorization, in each case to reflect the Transaction. LCE will remain the holder of the FTA authorization and the applicant in the non-FTA proceeding.

BGLS

BGLS holds multiple non-FTA, long-term LNG import authorizations, which are set forth in the table below ("BGLS Authorizations"). BGLS will remain the holder of the BGLS Authorizations.
