Dear Mr. Varagona:

Pursuant to that certain Amended and Restated Ship Loading Precedent Agreement, dated as of October 14th, 2016 (the "SLNG PA") by and between Shell NA LNG LLC ("Customer") and Southern LNG Company, L.L.C. ("SLNG"), Customer hereby authorizes SLNG to submit to the DOE the following information for the purposes of registering Customer with the DOE as a Person on whose behalf SLNG or its applicable Affiliate has the right to export pursuant to the SLNG Export Authorizations issued on June 15, 2012 (DOE/FE Order No. 3106), December 16, 2016 (DOE/FE Order No. 3956), and July 6, 2018 (DOE/FE Order No. 4206). All capitalized terms used but not defined herein shall have the meanings ascribed to them in the SLNG PA.

- 1. <u>Customer information.</u> Pursuant to the requirements of said SLNG Export Authorizations, Customer provides the information below, which is current and accurate as of the date of this letter:

- a. - contracts that it has executed to date associated with the long-term supply of natural gas to Elba Island pursuant to the SLNG Export Authorizations, as required by I(ii) of DOE/FE Order No. 3956.
- c. Customer hereby agrees to provide to SLNG, no later than five (5) Business Days prior to the relevant DOE deadline, a copy to be filed by SLNG with the DOE, of any contract meeting either of the descriptions set forth in Paragraph 2 (a) above.
- 3. <u>Updates.</u> Customer hereby agrees to provide SLNG with written notice and updated information with respect to the items listed below no later than five (5) Business Days prior to the relevant DOE deadline:
 - a. a change in its company name;
 - b. a change in its contact information;
 - c. a change in the term of any long-term contract described in paragraph 2. above;
 - d. the termination of any long-term contract described in Paragraph 2. above; and
 - e. any other relevant modifications to any of the contracts described or information provided in this letter.
- 4. Compliance with export Authorizations and Regulations. Customer hereby acknowledges and agrees to provide all information necessary to permit SLNG to register Customer with the DOE as required by the SLNG Export Authorizations referenced above. Customer further acknowledges and agrees to comply with such SLNG Export Authorizations and all applicable requirements of the DOE's regulations at 10 CFR Part 590, including but not limited to the destination restrictions set forth in such SLNG Export Authorizations. Customer agrees to sell or transfer LNG exported pursuant to the SLNG Export Authorizations referenced above only to entities that have agreed in writing to the destination restrictions and reporting requirements set forth in the Export Authorizations and have agreed to include such terms in all subsequent sales or transfers.
