Dear Ms. Sweeney:

Mitsui & Co. Cameron LNG Sales LLC ("MITCLS") has executed a long-term Liquefaction and Regasification Tolling Agreement with Cameron LNG, LLC ("Cameron") for service at Cameron's Liquefaction Project currently under construction in Hackberry, Louisiana.¹ Cameron holds several export authorizations ("Export Authorizations") that have been granted by the Department of Energy, Office of Fossil Energy ("DOE/FE").² Under the Export Authorizations, Cameron may export LNG as agent for other entities after the other entities are registered with DOE/FE. MITCLS will export domestically-produced LNG from the Cameron Liquefaction Project once commercial operations commence.

Pursuant to the Export Authorizations, MITCLS is supplying herewith its registration information to the Department of Energy's Office of Fossil Energy, Office of Regulation, Analysis and Engagement.


