Hello Amy,
I am sorry for missing your call.

NuBlu – Port Allen - The original FTA application in Docket # 18-27 did reflect the liquefaction capacity of 90,000 gallons which is the capacity (based on available pipeline gas) of Port Allen. We were planning for expansion at Port Allen which was the reason for the request. We currently have the ability to produce 3000 Mcf/d (1.095 Bcf/yr) at NuBlu Port Allen and would like the non-FTA application for Port Allen to reflect that volume.

Ehrenberg – You are correct as the liquefaction capacity at Ehrenberg is 6280 Mcf/d (2.292 Bcf/yr) and would like the non-FTA application to reflect this daily amount.

Let me know if this answers your question.

Cory – per the voicemail I just left, need make sure we have the correct requested amounts on the

liquefaction capacity of the two plants in your FTA and non-FTA applications:

In the original FTA application in Docket no. 18-27, the liquefaction capacity of the Port Allen NuBlu facility is listed as 2.715 Bcf/yr (90,000 gallons).

The amendment to 18-27 filed on August 19 says the Ehrenberg Spectrum facility is 6,280 Mcf/d which is 2.292 Bcf/yr (approximately 20 truck loadings/day)

The non-FTA application under the small scale rule is now requesting 3 Bcf/yr total and breaks down the facilities' capacities as 3,000 Mcf/d or 20 truck loadings per day for NuBlu, and Ehrenburg as 6,280 Mcf/d or 20 trucks per day.

It seems like there is not consistency on the capacity of the NuBlu facility; 2.715 Bcf/yr looks like 7,438 Mcf/d and not the 3,000 Mcf/d listed in the non-FTA appendix.

Either way you are under the small scale rule volume limit, but want to make sure we have the correct requested amounts if you are in fact looking to have the full liquefaction capacity of both facilities under your application requests.
