Dear Ms. Sweeney:

I write on behalf of Mexico Pacific Limited LLC ("MPL") to supplement the notification of a change in control of MPL which MPL submitted to the Department of Energy, Office of Fossil Energy ("DOE/FE") on November 18, 2019 in the captioned docket. This supplement responds to an inquiry from your office seeking additional detail concerning the identities of certain individuals who are now either directly or indirectly (through individual limited liability companies) owners of interests in MPL. It is submitted in accordance with the authorizations to export natural gas which DOE/FE granted to MPL in the captioned proceeding and the "Procedures for Changes in Control Affecting Applications and Authorizations To Import or Export Natural Gas" which DOE/FE adopted in November 2014.²

By means of a transaction that closed effective as of October 22, 2019, MPL's ownership has changed, with several new entities becoming holders of MPL membership interests, and two such holders (AVAIO MPL SPV, LP and DKRW Energy Partners LLC) increasing their ownership percentages by more than 10%. The purpose of this transaction was to secure sources of new capital to fund the continued development of the MPL project.

In its November 18, 2019 notice of change in control, MPL included a chart (labelled as **Exhibit A**) which describes the ownership of MPL membership interests both before and after the referenced transaction, and provides details as to the nature of the interests held by each equity holder as well as the percentage by which each such holder's ownership interests have changed. DOE/FE has recently asked MPL to identify by name the individual LLCs as well as the individual investor which are now owners of interests in MPL which were generally identified in Exhibit A. The revised chart attached to this letter, entitled "**Exhibit A** (revised 1/13/2020)," provides the exact names of the LLCs that were referenced in general terms in the original Exhibit A, as well as the name of the individual investor who has invested directly in MPL. The identified LLCs are owned by Page Maxson, Sarah Bairstow, Josh Loftus and Jacob Lewis, respectively. Other than Sarah Bairstow, each of these individuals, as well as John R. Collett (the individual investor who has invested directly), are citizens of the United States. Ms. Bairstow (who is MPL's Chief Commercial Officer) is a citizen of Australia.

As indicated in MPL's November 18, 2020 notice of change in control, the change in control resulting from the described transaction will not in any way affect the parameters of the LNG export project MPL described in its application and supplements filed in this proceeding. This change in control, therefore, presents no basis on which DOE/FE should modify the public interest determination it reached in granting the natural gas export authorizations MPL now holds.
