Dear Ms. Sweeney:

In the Department of Energy (“DOE”), Office of Fossil Energy’s (“FE”) Order No. 4508 issued February 28, 2020, in the above referenced docket, Dominion Energy Cove Point LNG, LP (“DECP”) was granted short-term, blanket authority to export liquefied natural gas (LNG); (1) to nations with whom the United States has entered into a free trade agreement requiring the national treatment of natural gas; and (2) to non-free-trade-agreement nations. The order permits DECP to use its authorization to export LNG as an agent for other entities, after registering the other parties with DOE/FE.

DECP<sup>1</sup> now submits the information necessary to register BP Energy Company (“BPEC”) as an entity for which DECP will utilize its authorization to export LNG, in

<sup>1</sup> On July 9, 2020, DECP notified the DOE, and provided notification of a planned transaction in which Berkshire Hathaway Energy Company (BHE), an Iowa corporation and a subsidiary of Berkshire Hathaway Inc., a Delaware corporation, will acquire indirect ownership and control of one hundred percent (100%) of the general partnership interests of DECP, and twenty-five percent (25%) of DECP’s limited partnership interests. In the July 9, 2020 filing DECP also indicated it expects BHE to change the name of the entity and will submit a future filing to DOE/FE to effectuate the name change for its export and import authorizations. On September 30, 2020, DOE responded to that notification, explaining that the change had been deemed granted. While that acquisition became effective on November 1, 2020, DECP’s name has not yet changed.

Pursuant to the Transaction Agreement dated as of October 28th, 2020 by and between BP Energy Company (BPEC) and Dominion Energy Cove Point LNG, LP (DECP), BPEC hereby authorizes DECP to submit to the Department of Energy, Office of Fossil Energy (DOE/FE) the following information for the purposes of registering BPEC with the DOE/FE as an entity on whose behalf DECP or its applicable affiliate has the right to export pursuant to the authorization issued on February 28, 2020 (DOE/FE Order No. 4508). In compliance with the requirements of Order No. 4508 and the October 28 Transaction Agreement, BPEC provides the information below, which is current and accurate as of the date of this letter.


